SUBJECT: Avenu Hotel Occupancy Tax Review - Final Report

The City of El Paso has contracted Avenu Insights & Analytics to conduct Hotel Occupancy Tax (HOT) Reviews in accordance with Contract No. 2015-633R. On May 29, 2020, Avenu Insights & Analytics concluded their review of HOT compliance for 19 El Paso area hotels. The period under review was from January 1, 2016 through December 31, 2019 (48 months). The review of the 19 hotels identified a total net credit of (\$21,279.83).

- Thirteen hotels had no findings.
- Five hotels had deficiencies totaling \$15,309.44.
- One hotel had a credit totaling (\$36,589.27) for overpayment of HOT Tax.
